## Membership fees

According to the resolution by the General Assembly on 5 November 2018, the ESSL annual membership fees (basis 2016) are:

Base membership fee, per calendar year, for organizations with at total number of

1 - 9 employees	€ 1100
10 - 24 employees	€ 3100
25 - 99 employees	€ 4100
100 - 249 employees	€ 6400
250 - 999 employees	€ 8500
1000 or more employees	€ 9900

The membership fee undergoes a yearly inflational compensation, based on the EUROSTAT Harmonized EU Consumer Price Index of the previous year.

Membership fees are to be paid annually until **30 March** of the respective calendar year to the bank account given below. The first membership fee is due on joining the association. Irrespective of the date of joining the association, the full annual membership dues have to be paid. In case of withdrawal, exclusion or death, there is no entitlement for reimbursement of membership fees (see also § 7 of the Articles of Association, available at [www.essl.org](http://www.essl.org)). Voluntary withdrawal occurs with written statement to the Executive Board. Withdrawal is only possible for the end of a calendar year, within a term of notice of three months (see § 8).
